**Footnotes:**

1. These items were owned by the Bouth Village Green Voluntary Committee on behalf of the village of Bouth, before April 2006 when the Committee became part of Colton Parish Council as the " Bouth Village Green and Playground Advisory Committee".
2. These boards were made by Peter Helme of Water Yeat and are placed at Lakeside (made in 2005), Oxen Park (2005), High Nibthwaite (2011) and Rusland (2015).
3. These boards were made by Signs by Design of Kendal, were cheaper but have mostly fallen apart – not up to the exposed weather conditions – and are gradually being disposed of.
4. This board was kindly made by Mr Ron Mein of Bouth for the cost of materials only.
5. New notice-board at Finsthwaite, received free of charge via County (Community Transport), in 2013.
6. New aluminium notice-board bought for Bouth in March 2015.
7. In 2016, it was decide to buy a cheap plastic board to be fitted onto Oxen Park gig-house door, sheltered from the weather. The original board (see under 2. Above) will be removed and placed at Colton to replace the original board (see under 3. above).
8. Fixed assets of less than £2000 are charged to the Income and Expenditure A/c in the year of purchase. Most items are depreciating items. They are insured for their replacement value.
