The Local Government Audit and Accountability Act 2014 meant that the public had the right to film or record meetings, except in situations where such activity caused disruption to the meeting or in situations where the press and public had been excluded. The regulations had been circulated to all Councillors.	
113/14 Update on Issues and Actions from Last Meeting <u>Community Plan:</u> The working group had met again to discuss and finalise the wording of the Plan's Policies and Actions. They were now in the process of reviewing the full Plan before circulation for wider comment.	
114/14 Public Participation Mr Peter Evoy (SCRT) and Mr Brendan Burley (CWT) gave a presentation on two related planning applications concerning i) the Rusland Pool tide gate at Pool Bridge, Bouth and ii) the restoration of Ireland Moss. The first of these was before the Council under item 9. Planning. The Cumbria Wildlife Trust had been approached by Penny Bridge Estates to undertake the restoration of Ireland Moss, an area of wetland between the Causeway, Bouth and the A590. This would involve clearance of rhododendron and c. 13ha of Scott's pine and Sitka spruce to create an open habitat. The process would be similar to that carried out at Foulshore Moss, with bunding 15-20cm high, slowing the water egress from the site. A forestry strip alongside the A590 would remain as well as a fringe of broadleaves around the site. Concern was expressed about the loss of the shielding effect the woodland gave from the A590 for nearby residents as well as any increase in flooding problems. Mr Burley reassured the Council that the works would not cause increased flooding of the Causeway. The replacement of the tide gate at Pool Bridge was necessary for the restoration of the Moss. The gate would be replaced along with the headwall and culvert. This would control tidal surge and saline intrusion, and would reduce flooding and undercutting damage to the causeway road and footpaths along the river. The new tide gates would have valves to allow fish and eels to pass upstream. The Environment Agency used to maintain these gates but no longer did so. Maintenance of the tide gate, once replaced, would be the responsibility of the land-owner.
