



CHILD PROTECTION AND SAFEGUARDING POLICY

Policy Statement

In the interests of child protection and the welfare and protection of vulnerable adults, Colton Parish Council is committed to ensuring that children and vulnerable adults are protected and kept safe from harm whilst they are engaged in any activity associated with the Parish Council. Safeguarding children and vulnerable adults is everyone's responsibility.

In this policy a child is defined as a person under the age of 18 (The Children Act 1989).

Aims

The aim of this policy document is to guide members of Colton Parish Council should any child protection issue or any issues with vulnerable adults arise during the undertaking of Parish Council work.

Policy Objectives

- To ensure that where possible all activities offered by the Parish Council are designed and maintained to reduce the risk to children and vulnerable adults
- To promote the general welfare, health and development of children by being aware of child protection issues and to be able to respond where appropriate as a local government association
- To develop procedures in recording and responding to accidents and complaints and to alleged or suspected incidents of abuse and neglect in relation to PC organised events
- As the Parish Council does not directly provide care of supervision services to children and vulnerable adults, it expects all children and vulnerable adults attending its events to do so with the consent and the necessary supervision of a parent, carer or other responsible adult

Responsibilities and Procedures

The Council will:

- Nominate a PC Safeguarding Lead, currently Cllr Abigail Bennett
- Ensure that before any Parish Council organised event with children or vulnerable persons, the Safeguarding Lead briefs Councillors and participants appropriately
- Ensure that members are aware of the risk they may face in certain circumstances whilst carrying out their duties
- Ensure that whilst Council members are unlikely to be involved with children during the performance of their duties, they are mindful of the risk they face when doing so
- Undertake Level 1 awareness raising training, with additional training should the frequency/likelihood of working with children, young people or vulnerable adults increase
- Decide whether any person should be DBS checked after consultation with the Clerk following a risk assessment

All Councillors are to be provided with a copy of the Safeguarding Policy and are required to acknowledge and sign to confirm they will abide by it. All new Councillors will also be required to sign.

- Councillors will adhere to the 'List of Recommended Behaviour' namely:
 - A minimum of two adults present when supervising children

- Not to play physical contact games
 - Adults to wear appropriate clothing at all times
 - Ensure that accidents are recorded in an accident book
 - Never to undertake personal care or have inappropriate contact with an individual who is vulnerable through either age or recognised protected characteristics, where they are not a carer or member of the persons family
 - Keeping records of any incidents or allegations a person made to any committee member or volunteer
 - Sharing information about child protection and good practice with partner organisations, councillors, employees, volunteers, parents and carers
- In the event of a contractor, working directly for the Parish Council, being deemed to be working in any area where children or vulnerable adults may be at risk, then that contractor will be asked to provide their Safeguarding Policy
 - Any organisation which may make contact with children or vulnerable adults shall be required to show proof of its own appropriate Safeguarding Policy before being allowed to participate in Council managed events

Photography

All photography should take place in a public setting whenever young people are involved. The child or young person should be happy with having their picture taken. The names of children or young people should not be used in photographs or video footage, unless with the express permission of the child or young person's parent.

There may be occasions when photographs of groups of children are taken at public events, e.g., at the opening of a playground. Permission to use such images in the press, in village magazines, or on the website would not normally be expressly sought; this is common practice.

Declaration

Colton Parish Council is fully committed to safeguarding the well-being of children and vulnerable adults by protecting them from physical, sexual, emotional harm, neglect including cyber bullying, sexting and peer on peer abuse.

All members of Colton Parish Council should read the Safeguarding Policy. Having read the Policy, they should be proactive in providing a safe environment for children and vulnerable people who are involved in Parish Council activities.
